

SOFTWARE LICENSE AGREEMENT

1. Introduction and Acceptance. This is a legal agreement between you (either an individual or a single entity) and Omsphere LLC ("Omsphere") regarding Omsphere's currently available MITS software version(s) provided in electronic form by way of this software end user license agreement ("Software"). BY INSTALLING OR USING THIS SOFTWARE, YOU AGREE TO BE BOUND BY ALL OF THE TERMS OF THIS SOFTWARE LICENSE AGREEMENT ("AGREEMENT"). BEFORE YOU USE THIS SOFTWARE, CAREFULLY READ THE TERMS AND CONDITIONS OF THIS AGREEMENT. **IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, YOU MUST DEINSTALL AND REMOVE THIS SOFTWARE FROM YOUR COMPUTER.**

2. License. Subject to the restrictions set forth below, Omsphere grants to you, and you hereby accept, a non-transferable, non-sublicenseable, non-exclusive license during the Evaluation Period to install and use, solely for internal evaluation purposes, one (1) copy of the Software, in object code only and only on the computer for which you have obtained the requisite license key from Omsphere ("Licensed Machine").

3. Use Restrictions. This Software is licensed to you for internal evaluation use only. You hereby acknowledge that the scope of the license granted hereunder does not permit you (and you shall not allow any third party) to: (i) decompile, disassemble, reverse engineer or attempt to reconstruct, identify or discover any source code, underlying ideas, underlying user interface techniques or algorithms of the Software by any means whatever, or disclose any of the foregoing; (ii) provide, lease, lend, use for timesharing or service bureau purposes, or otherwise use or allow others to use the Software for the benefit of third parties; (iii) modify, incorporate into or with other software, or create a derivative work of any part of the Software; (iv) remove any proprietary notices or labels on the Software; (v) use the Software for any commercial purposes; (vi) disclose the results of any benchmarking of the Software, or use such results for its own competing software development activities, without the prior written permission of Omsphere; or (vii) attempt to circumvent any user limits, maximum gate count limits or other license, timing or use restrictions that are built into the Software.

4. Copy Restrictions. This Software is protected by United States copyright laws and international treaty provisions. Unauthorized copying of the Software in whole or in part is expressly forbidden. Subject to these restrictions, you may load the Software onto the Licensed Machine to support authorized use.

5. Transfer Restrictions. You shall not sublicense, transfer or assign this Agreement or any of the rights or licenses granted under this Agreement.

6. Ownership of the Software. Omsphere retains all right, title, and interest in the Software and any complete or partial copies thereof or modifications and updates thereto, and reserves all rights not expressly granted to you. This License is not a sale of the original Software or of any copy.

7. Protection of Confidential Information. The Software contains confidential and proprietary information ("Confidential Information"). Specifically, Confidential Information includes (i) the Software, in object and source code form, and any related technology, idea, algorithm or information contained therein, (ii) Omsphere's product plans, designs, costs, prices and names; non-published financial information; marketing plans; business opportunities; research; development or know-how; (iii) any information designated by Omsphere as confidential in writing or, if disclosed orally, designated as confidential at the time of disclosure; provided however that "Confidential Information" will not include information that: (a) is or becomes generally known or available by publication, commercial use or otherwise through no fault of your own; (b) is known and has been reduced to tangible form by you at the time of disclosure and is not subject to restriction; (c) is independently developed by you without use of Omsphere's Confidential Information; (d) is lawfully obtained from a third party who has the right to make such disclosure; and (e) is released for publication by Omsphere in writing.

You will not provide, disclose or otherwise make available Omsphere's Confidential Information, in any form to any person other than your employees for the purposes contemplated in this Agreement, and you shall keep all Confidential Information in strict confidence. Any use or attempted use of the Confidential Information in violation of the restrictions contained in this Section 7 is a breach of this Agreement which will cause irreparable harm to Omsphere entitling Omsphere to injunctive relief in addition to all legal remedies. You shall take appropriate actions, including without limitation establishing written guidelines, in connection with your employees who are allowed access to the Confidential Information to satisfy your obligations under this Agreement with respect to use, copying, modification, disclosure, disposition, protection, and security of the Confidential Information.

8. Evaluation Period and Term of Agreement. The "Evaluation Period" is defined as the period of time authorized through a license key provided by Omsphere, but is limited to forty-five (45) days after the download if no license key is provided. At the end of the Evaluation Period, this Agreement (and all rights and licenses granted under this Agreement) shall terminate without further notice to you, and the Software shall cease to function for use on the Licensed Machine. If you wish to extend the Evaluation Period, you may request an extension and accompanying license key by contacting Omsphere. Extension of the Evaluation Period shall not

take effect unless you obtain a new license key from Omsphere authorizing an extended evaluation period. Notwithstanding any provision herein, you understand that your license to the Software will automatically expire at the end of the Evaluation Period, or if an extension has been obtained, at the end of any such extension. If you wish to obtain a license that exceeds the scope of the license contained in this Agreement, you must contact Omsphere, provided however, no such license shall take effect unless you and Omsphere execute a written agreement.

9. Termination. Omsphere may terminate this Agreement for any reason at any time. Upon termination, you shall relinquish all rights under this Agreement, and must cease using and return or destroy the Software, as well as any and all copies (and partial copies) of the Software.

10. Export. You agree not to allow the Omsphere Software to be sent or used in any country not in compliance with applicable U.S. laws and regulations.

11. Disclaimer of Warranty. This free-of-charge Software is provided on an "AS IS" basis. NO WARRANTIES OR CONDITIONS, EITHER EXPRESS, IMPLIED, STATUTORY OR OTHERWISE ARE MADE BY OMSPHERE WITH RESPECT TO THE SOFTWARE AND ANY ACCOMPANYING DOCUMENTATION, AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, OMSPHERE EXPRESSLY DISCLAIMS ALL WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT, AND FITNESS FOR A PARTICULAR PURPOSE. OMSPHERE DOES NOT WARRANT THAT THE FUNCTIONS CONTAINED IN THE SOFTWARE WILL MEET YOUR REQUIREMENTS, BE UNINTERRUPTED OR ERROR FREE, OR THAT ANY DEFECTS IN THE PROGRAM WILL BE CORRECTED. You assume the entire risk as to the results and performance of the Software; in other words, should the Software prove defective, you and not Omsphere assume the entire cost of any service and repair. Some states/jurisdictions do not allow the exclusion of implied warranties, so the above exclusion may not apply.

12. Limitation of Liability. YOU AGREE THAT IN NO EVENT SHALL OMSPHERE OR ITS AGENTS BE LIABLE FOR ANY INDIRECT, SPECIAL, CONSEQUENTIAL, PUNITIVE OR INCIDENTAL DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR GOODWILL, LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTIONS, LOSS OF BUSINESS INFORMATION, LOSS OF DATA OR OTHER PECUNIARY LOSS) ARISING OUT OF THE USE OF OR INABILITY TO USE THESE OMSPHERE PRODUCTS, EVEN IF OMSPHERE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. Some states/jurisdictions do not allow the limitation or exclusion of incidental or consequential damages, so the above limitations or exclusions may not apply.

13. Miscellaneous. If you (the party licensing the Software by way of this Agreement) are a corporation, partnership or similar entity, then the license to the Software that is granted under this Agreement is expressly conditioned upon acceptance by a person who is authorized to sign for and bind you. This Agreement is the entire agreement between you and Omsphere with respect to the license to the Software, supersedes any previous oral or written communications or documents (including, if you are obtaining an update, any agreement that may have been included with the initial version of the Software), and may be amended or modified only by a writing executed by both parties. This Agreement is governed by the laws of the State of California, USA, without reference to conflicts of law principles. This Agreement will not be governed by the U.N. Convention on Contracts for the International Sale of Goods. The federal and state courts within San Francisco, California shall have exclusive jurisdiction to adjudicate any dispute arising out of this Agreement, and you hereby expressly consent to the personal jurisdiction of the federal and state courts within California. If any provision of this Agreement is found to be invalid or unenforceable, it will be enforced to the extent permissible and the remainder of this Agreement will remain in full force and effect. Failure to prosecute a party's rights with respect to a default hereunder will not constitute a waiver of the right to enforce rights with respect to the same or any other breach. The provisions of Sections 3, 4, 5, 6, 7, 9, 10, 11, 12, 13 and 14 shall survive any termination of this Agreement.
